2019 Home Insurance Promotion

INCENTIVE PROMOTION

The incentive promotion will run for the following dates; May 1, to June 30, 2019 and September 15 to December 31, 2019 at 11:59 PM PST, (the “**Incentive Promotion Period**”). All new Home Insurance policy purchases or quotes must be completed during this Incentive Promotion Period for you to be eligible for the \$50 incentive.

To be eligible for the \$50 incentive you must meet with an Interior Savings Insurance Services Agent and let them know you either saw an online digital ad, saw branch creative elements or received an e-blast with the incentive offer.

You will be eligible for the \$50 incentive automatically when you purchase a New Home insurance policy as part of the promotion, during the Incentive Promotion Period.

You will also be eligible for the \$50 incentive automatically when you receive a New Home insurance policy quote during the Incentive Promotion Period and purchase the new policy within 1-year of receiving the New Home Insurance quote. No quotes from this promotion will be honored beyond December 31, 2020 at 11:59 p.m.

You do not need to be an existing member of Interior Savings to participate in the Home Insurance Incentive Promotion.

The promotional offer is open to all residents of British Columbia who are 19 years of age or older who live within our British Columbia Insurance boundaries, except employees, representatives or agents of Interior Savings Credit Union, its wholly or partially owned subsidiaries, its advertising agencies, its judging organization(s), and any family members with whom any of the foregoing individuals reside.

TO RECEIVE THE \$50 INCENTIVE

Members and non-members who purchase a new Home Insurance Policy during the Incentive Promotion Period will be mailed a \$50 incentive cheque directly from Interior Savings Insurance Services once the new Home Insurance policy has been purchased and issued by the Insurance Company.

Interior Savings may request valid proof of identity, residency, age and other relevant documentation, and Interior Savings may disqualify an entrant in the Home Insurance Incentive Promotion if Interior Savings determines (in its sole discretion) that the provided proof is not sufficient or accurate.
